Subject:- Steering Committee on <u>Urban Development</u>, <u>Urban Housing and Urban Poverty</u> for the <u>Eleventh Five Year Plan (2007-2012)</u>.

## 2. Terms of Reference

- (1) To review critically the policies, performance of various schemes and programmes in operation in the Tenth Plan in respect of Urban Development, Urban Housing, Urban Poverty, Slums and their relevance in the Eleventh Plan. Committee would keep in view the Mid Term Appraisal of Tenth Plan.
- (2) To review policy on Urban Transport, current and future needs of Urban Transport including poor, provision of Mass Rapid Transit System (MRTS), Land use and Transport Planning, integration of various modes of transport, principle of cost sharing between State and Centre.
- (3) To review urban Housing needs, creation of data base both GIS and spatial based, policy for housing for slum dwellers and EWS, land tenure, low cost/ eco friendly technologies for house construction, credit needs including micro credit to urban poor, building byelaws, availability of finances and new instruments for self employed and poor, development of rental housing, policy for new townships, etc.
- (4) To suggest ways for convergence of basic services like education, health, social security etc including generation of livelihood/ employment opportunities under various schemes, feasibility of launching Employment Guarantee Scheme in urban areas.

- (5) To identify thrust areas in urban governance (including e-governance and financing of ULBs), implementation of 74<sup>th</sup> Constitutional Amendment, etc.
- (6) To review the status of City Development Plans-preparation and updation in the light of city vision.
- (7) To suggest ways and means for development of infrastructure for basic urban services such as drinking water, sanitation, sewerage, solid waste management, sports facilities, parks and also explore scope for PPP and FDI/EAP in urban infrastructure/ services
- (8) To review the status of conservation of heritage site, ecology etc.
- (9) To suggest objectives, policies, strategies and programmes, disaggregated targets of 11<sup>th</sup> Plan
- (10) To examine and make recommendations regarding all matters relevant and incidental to the above Terms of Reference
- 3. The Chairman of the Steering Committee may co-opt any additional member(s), official or non-official and constitute Sub Groups, if deemed necessary.
- 4. TA/DA for the official members of the Committee for attending meetings of the Committee shall be borne by the respective Ministries/Departments/State Governments to which the members belong as per their rules. In the case of non-official members, expenditure on TA/DA will be borne by the Planning Commission as admissible to Class I Officers of the Government of India as per SR 190(a).
- 5. The Committee will submit its report within a period of three months.
