- 3. The Terms of Reference are as follows:-
- (a) Assessment of the current investment scenario.
- (b) Estimation of the aggregate investment requirement broad sector-wise during the Twelfth Five Year Plan for achieving GDP growth target.
- (c) Projection of private investment demand comprising corporate investment and household sector investment.
- (d) Assessment of state level growth prospect.
- (e) Inter state and intra-state income inequality.
- (f) State specific growth scenario in agricultural sector.
- (g) Infrastructure development at state level.
