Terms of Reference (TOR) of the Working Group on Adolescent & Youth Development – Twelfth Five Year Plan (2012-2017)

- To review the existing approach, strategy, priorities, on going policies and Plan programmes, and their implementation including physical and financial targets for the benefit of Adolescents and Youths, particularly with reference to the Twelfth Five Year Plan, both in government and non-government sectors;
- To suggest rationalization of the ongoing programmes and effective intersectoral convergence;
- To review the status of adolescent and youth affairs schemes/ programmes and to focus attention for the development perspective for these sectors for the Twelfth Five Year Plan.
- 4. To identify the neglected areas and groups; gaps, weaknesses and bottlenecks and to take note of the persisting and emerging problems / situations related to adolescents and youths and to suggest the future directions of the programmes including expansion and qualitative upgradation in terms of standards, facilities and attainments with special reference to the adolescent and youth activities in rural and tribal areas;
- 5. To suggest measures to create effective linkages between different organizations engaged in the sector and better utilization of existing and created infrastructure/ facilities;
- 6. To critically examine the resource assessment under different activities/programmes and to suggest the *ways and means* for mobilization of additional resources:
- 7. To examine private sector participation as also the involvement of non-govt. organizations/ community/other private organizations, Panchayati Raj Institutions in the programmes under this sector;
- To make recommendations regarding policy, programme priority and financial outlays to achieve the goals and objectives set for the 12th Five Year Plan in respect of adolescents and youths;
- 9. To review the functioning of the existing administrative structures and mechanisms, both at the Central and State levels, and suggest modifications to foster integrated implementation of XII Plan programmes for youth affairs with active participation of State governments
- 10. To examine and make recommendations regarding all other matters relevant and incidental to the above term of reference.
