- 2. The Terms of Reference of the Working Group will be as follows:
 - i. To assess Planning Commission's existing relationship with institutions of higher learning, universities, research institutions, research bodies and mechanism for getting feed back on research and findings.
 - ii. Suggest ways for enhancing interaction between Planning Commission and research bodies, think tanks, scholars and academia.
 - iii To review working of existing Chairs and Units and examine whether they need to be maintained and whether pruning will be possible.
 - (b) To take a view on whether the amount of Endowment grant provided by Planning Commission can be increased during the 12th Five Year Plan to any particular university/institution.

- i٧. To consider the need for strengthening research capability of institutions for undertaking multidisciplinary research in areas of public policy including scope for commissioned and collaborative studies.
- To consider funding needs of such institutions in the light of attracting the best ν possible talent for such initiatives.
- vi. To consider model MOUs to be signed between Planning Commission and Universities/Institutions, individuals to ensure commitment and compliance.
- Measures to strengthen SER Division including posting of Senior Technical Officers vii. having background orientation of social science in SER Division to co-ordinate and handle the increase in volume of work.
- The Chairman may co-opt experts for specific tasks. The Group may consider any other issue which it may consider relevant. if felt necessary.
- The Working Group will submit its report in the Planning Commission by 30th June, 4. 2012.
- The expenditure on TA/DA of official members of the Working Group will be borne by their respective Ministry/Department of Central Government as per the rules of entitlement applicable to them. TA/DA for non-official members will be borne by Planning Commission as per SR 190(a).
