# 1. Microbiology/Michael J. Pelczar, JR







### 5. Facets of Vigilance/K L Malhotra



# 6. Urbanisation in India/Isher Judge Ahluwalia





### 8. Mirrored Mind: My life in Letters and Code/Vikram Chandra


