The Transport Division, Planning Commission requires the services of one Non-official Consultant with the following qualifications and job description: -

**Job Requirement**

- (i) Detailed work relating to the Transport Sector i.e. Railways, Roads, Ports and Civil Aviation particularly in respect of assessment of resources.
- (ii) Carrying out-in-depth study of State Road Transport Corporations.
- (iii) Carrying out studies relating to Transport Sector.
- (iv) To assist in the coordination of work relating to various committees set up for the development of Transport Sector.
- (v) To assist in the coordination of work relating to 12<sup>th</sup> Five Year Plan.
- (vi) Any other miscellaneous work.

**Essential Qualifications and Experience**

- (i) Candidates holding Master's Degree in Statistics, Economics, Mathematics, Engineering and Social Sciences from a recognized University.
- (ii) Candidates should have a Ph.D Degree in relevant subject and minimum post qualification experience of 10 years in the requisite field.
- (iii) Retired Government employees with (i) Grade pay of Rs.7,600 and above & (ii) at least 10 years experience in the required domain field would also be eligible for this position.

- (iv) Knowledge of computer application, SPSS, MS Office including Excel, Access etc.

**Desirable**

- (i) Strong communication skills, both oral and written.
- (ii) Capable of data analysis and with ability to generate a well research and written report.
- (iii) Experience in collection, compilation and analysis of data.

**Duration**

- (i) Candidates selected will be appointed on contract basis for an initial period of one year. Further continuance upto a maximum total period of five years will be considered as per the Planning Commission's need and performance of the candidate.

**Age limit**

- (i) The maximum age limit shall be 65 years.

**Remuneration**

- (i) The remuneration shall be in the range between Rs.40,000/- to Rs.70,000/- per month depending upon educational qualification and work experience of the selected candidate. The amount will be consolidated and inclusive of all allowances.
- (ii) The remuneration in the case of retirement Government officials shall be decided in such a way that the fee plus pension drawn by him/her shall not exceed the last pay drawn.
