Officers working under the Central / State Governments / Universities/ Recognized Research Institutions / Public Sector Undertakings / Semi-Government, Statutory or Autonomous Organizations alongwith Departmental Research Officers, who fulfill the conditions specified in *Annexure-I*, shall be considered for selection to the post. In case, any Departmental Research Officer is selected by the UPSC for appointment to the post, that post shall be deemed to have been filled by promotion and in case, an outsider is recommended by the UPSC, the post will be offered on transfer on deputation / short-term contract basis, as the case may be.

- 4. 1. SCALE OF PAY:

2. **DUTIES ATTACHED TO THE POST:**
