#### (i) Precise statement of Objectives:-

Power & Energy Division comprises of four units, Power, Coal, Petroleum and Energy Policy. Together these units review the energy situation in the country. This Division analyses various issues pertaining to the energy security of the country and examines technical, financial and economic viability of investment projects in the energy sector and their appraisal. Preparation of Five Year Plan and Annual Plan for the Energy Sector is key work of the Division.
