## Deputy Adviser (Fisheries)

#### **ESSENTIAL:**

- (i) Master's Degree in Veterinary Science/ Animal Husbandry/ Fisheries or related field or discipline of a recognised University or equivalent.
- (ii) 10 years' experience in research/ development/ planning/ execution of development projects/ programmes in the field of fisheries inland/ marine.
