If a Departmental Deputy Adviser of Planning Commission is recommended by UPSC for appointment to any of these posts, it will be treated as having been filled by Promotion and in case any outside candidate is recommended by UPSC, the post will be offered on Deputation basis for a specified period, as per the provisions of Recruitment Rules.
- 3. Scale of pay, eligibility conditions i.e. qualifications and experience, period of deputation and duties etc. for each post are indicated in the enclosed Annexure.
- 4. 1. **SCALE OF PAY** : Rs.14300-400-18300 [For each post]

2. <u>DUTIES **ATTACHED TO THE POST**</u>:

[I] Joint Adviser (Power)

- 1. Planning and Programming for the development of Power Sector and then integration with national economic plans through the operational mechanism of Annual and Five Year Plans.
- 2. Integration of Power plans with other sectoral development by functioning in cooperation with the concerned Ministries, State Governments, Public Sector undertakings, Institutions, Agencies, etc.
- 3. Representing Planning Commission in meetings, Committees, Inter-Ministerial Groups, etc. for feed back to Planning Commission for decision making, examining various papers/notes/reports etc. received in the Planning Commission relating to the Sector.
- 4. Appraisal of projects/feasibility reports and monitoring of the performance of the Power Sector as integrated to other related sectoral developments, developing and coordinating studies aimed at resolving the problems at various higher levels and preparing specialized technical papers.
- 5. Supervision of the work of the Power Unit.
- 6. Such other duties as may be assigned by the Planning Commission.

(II) Joint Adviser (Industrial Economics/Management)

- 1. Joint Adviser will be responsible for general issues of economic and industrial policies and programmes and coordination work in the Industry and Minerals Division.
- 2. Examination, formulation and review of the policies and programmes covering general issues, prices, fiscal and financial levies, export, import and comparative advantages thereto including other aspects related to international trade.
- 3. To undertake studies on various aspects of industrial economics and management.
- 4. Formulation and examination of proposals received from various Ministries/State Governments including aspects covering general economic and industrial issues.

- 5. Participation in apex Government agencies dealing with industrial programmes viz. Development Councils, licensing Committees, Project Appraisal Board, Foreign Investment Board, Capital Goods Committee, NRS Committee etc.
- 6. Examination of Notes for Cabinet/Cabinet Committees/ Group of Ministers/Committees of Secretaries etc.
- 7. Maintaining coordination with various Central Ministries/Departments/State Governments etc. regarding matters, policies, programmes and general issues concerning economic development.
