Subject: Recruitment to one post of Senior Research Assistant (Education) [redesignated as Economic Officer (Education)] in the Planning Commission on deputation basis.

Sir,

I am directed to say that the Planning Commission proposes to fill up one post of Senior Research Assistant (Education) [redesignated as Economic Officer (Education)] in the scale of pay of Rs. 6500-200-10500 on deputation basis and accordingly invites applications from the willing and eligible officers. The details regarding educational qualifications, experience and other eligibility conditions required for the post, the period of deputation etc. are indicated in the enclosed Annexure.

2. Ministries / Departments of the Central Government are requested to bring this vacancy to the notice of officials working under their control and also in their attached/Subordinate offices and forward the applications of those who are eligible and interested and who can be spared for taking up the assignment within one month of the intimation, if selected. The applications should be strictly in the enclosed proforma (in duplicate) duly signed by the candidate and certified by the Head of Office or an officer authorised to sign on his behalf. The applications of eligible candidates should accompany the following documents: -

- (a) Specific No objection/Cadre clearance;
- (b) Up-to-date Confidential Report Dossier or photocopies of Annual Confidential Reports for the last five years of the candidate concerned, duly attested by an officer not below the rank of Under Secretary to the Govt. of India ;

- (c) Vigilance Clearance in the enclosed format indicating that no disciplinary proceedings or criminal proceedings are either pending or contemplated against the officer concerned;
- (d) Integrity Certificate, in the enclosed format, duly signed by an officer not below the rank of Deputy Secretary to the Govt. of India; and
- (e) Details of major/minor penalties, if any, imposed upon the candidate during the last ten years or 'No Penalty Certificate' in the enclosed format, as the case may be.

3. The vacancy is also being published in the Employment News. Last date for receipt of applications in the Planning Commission shall be 60 days from the date of publication of this advertisement in the Employment News. The eligibility of the candidates shall be determined as on the last date for receipt of applications. Applications complete in all respects may be sent to Under Secretary (A-2), Planning Commission, Room No. 516, Yojana Bhavan, Sansad Marg, and New Delhi-110001 so as to reach him on or before the closing date as per the publication in the Employment News.
