- (e) Details of major/minor penalties, if any, imposed upon the candidate during the last ten years or 'No Penalty Certificate' in the enclosed format, as the case may be.

The last date for receipt of applications in the Planning Commission shall be 30 days from the date of publication of this Vacancy Circular in the Employment News/Rozgar Samachar.
