(ii)	2.3.4 in Request for Proposal	An Applicant, as well as any of its affiliates, eventually appointed to provide Consultancy for this assignment shall be disqualified from subsequently providing goods or works or services related to the construction and execution of the same assignment (other than a continuation of the firm's earlier consulting services) and any breach of this obligation shall be construed as Conflict of Interest.
