- 3. The Complete Tender Document may either be downloaded from the website of the Planning Commission (www.planningcommission.gov.in) or collected from General I Section Room No. 443, Yojana Bhawan, Sansad Marg, New Delhi on any working day between 3.00 PM to 4.00 PM till 30.09.2010.
- 4. The technical Bid shall be opened at 4.00 PM on 01.10.2010 in Room No. 507, Yojana Bhawan in the presence of such bidders or their authorized representatives who may wish to be present. The Financial Bid of only those bidders whose technical bid have been accepted will be opened at 3.30 PM on 04.10.2010 in Room No. 507 in the presence of successful bidders or their authorized representatives.
- 5. Bids received after the closing date and time shall not be considered.
- 6. The Planning Commission reserves the right to reject any or all tenders without assigning any reason and the decision of the Planning Commission shall be final and binding.

#### **Eligibility Criteria**

The firm giving tender should meet the following eligibility criteria:-

- (a) It should be registered for Sales Tax / VAT/ Trade/Service Tax. A self attested copy of Registration Certificate should be attached.
- (b) The firm should not have been blacklisted and it should furnish self certificate to this effect that "it is certified that the M/s...... has not been blacklisted by any Govt. Organisation / D.G.S & D/ NCCF/Kendriya Bhandar during last three years."
- (c) The bidder should have supplied/installed audio system within the last two years to, Government Departments/Ministries/PSUs etc as on 31.08.2010. Supporting document to this effect to be enclosed with the technical bid.
- (d) The bidder should be authorised dealer / distributor of the DIS Audio conference system. A valid authorisation letter from the Original Equipment Manufacturer(OEM) should be attached in original with the Technical Bid.

#### General information & terms and conditions

(i) Scope of Supply: -

The scope of Supply will cover:

- (a) Removal of the existing 52 boundary Layer Microphones (Crown MB3 Make) and six Mixers (AKG AS 8TC) from the Committee Room No.122 (SANGAM).
- (b) Provision, installation, testing and commissioning of fully digital conference system(DCS 6000 of DIS Make) in Committee Room No.122 (SANGAM) with gooseneck Microphones and their integration with existing PA system i.e. Amplifier, speakers and other equipments installed in the committee room for simultaneous video presentation.
- (c) Installation of existing Boundary Layer Microphones & Mixers removed from Committee Room No.122 (Sangam) alongwith other necessary audio equipment such as amplifier, speakers (to be newly provided) in three Committee Rooms namely "KANGRA", "MADHUBANI", and "BAITHAK".
- (d) Provision and installation of electronic **Off/On switch with LED indicator** for each boundary layer microphones in KANGRA, BAITHAK and MADHUBANI.

- (ii) The bidder may inspect the existing audio system in the committee room after taking prior appointment on any working day till 29.09.2010. The successful bidder will have to supply, install, test and commission (SITC) the digital conference system in "SANGAM" and the audio system in other three committee rooms within 21 days from the date of placing the order.
- (iii) Detailed specifications of items required are given in the tender document. Colour picture catalogues clearly indicating the items / equipments should be attached with the Technical Bid.
- (iv) The tenderers are required to submit two separate bids Technical and Financial, as per proforma given in the tender document. The two bids should be put in two separate sealed envelopes superscribed "Technical Bid" and "Financial Bid". Both sealed envelopes should be put in a third sealed envelope superscribed "Supply of audio equipments for installation of audio system in four committee rooms in Yojana Bhawan".
- (v) The Technical Bid should be accompanied by an Earnest Money Deposit (EMD) of Rs.60,000/- (Rupees Sixty thousand only) in the form of Demand Draft/Pay Order from a commercial bank drawn in favour of "Pay & Accounts Officer, Planning Commission, New Delhi". It should remain valid for a period of 6 months from the date of issue of the bid invitation. In the absence of EMD, the tender shall be rejected summarily. The EMD of unsuccessful bidders shall be returned after finalisation of the contract. No interest shall be paid on EMD.
- (vi) The successful bidder will deposit a Performance Security of Rs.1,25,000/- (Rupees One lac twenty five thousand only) or five percent of the bid amount which ever is higher in the form of a Fixed Deposit Receipt from a commercial bank and hypothecated in favour of "Pay & Accounts Officer, Planning Commission, New Delhi" valid for 60 days beyond the expiry of period of one year of warranty from the date of award of the work order and the same shall remain in the custody of Planning Commission for a period of 14 month.
- (vii) TDS will be deducted at source as per Rules.
- (viii) The bidder should submit its Certificate from OEM for being Authorized Dealer/Distributor/Channel partner.
- (ix) The supplied items should be under warranty for a minimum period of one year from the date of supply of the items. In case of any manufacturing defect, the item should be replaced with new one without any extra charge.
- (x) For after sales services during the period of warranty, the successful bidder shall be contactable at all times and message sent by the Tel/E-mail/Fax to it shall be acknowledged immediately on the same day.
- (xi) During the warranty period, the firm shall provide on-site maintenance within 24 hours of registering a complaint with the firm
- (xii) All entries in the tender form should be legible and filled clearly. Any cutting in the Bid Application must be signed by the authorized signatory.

- (xiii) Conditional bids shall not be considered and will be rejected outright.
- (xiv) Tender incomplete in any respect is liable to be rejected out rightly.
- (xv) The closing time and date for receipt of tenders will be 3.00 P.M. on 01.10.2010.
- (xvi) The Technical Bid shall be opened at 4.00 PM on 01.10.2010 in Room No.507, Planning Commission, Yojana Bhavan, Sansad Marg, New Delhi, in the presence of such tenderers or their authorized representatives who may wish to be present.
- (xvii) The Financial Bids of the tenderers whose technical bid will be accepted shall be opened at 3.30 PM on 04.10.2010 in Room No.507, Planning Commission, Yojana Bhavan, Sansad Marg, New Delhi, in the presence of such tenderers or their authorized representatives who may wish to be present.
- (xviii) No bidder will be allowed to withdraw after submission of the bids; otherwise the EMD submitted by the bidding firm would stand forfeited.
- (xix) L1 will be decided on the basis of total lowest quote.
- (xx) In case the successful bidder declines the offer of contract, for whatsoever reason(s), the EMD submitted by the successful bidder shall stand forfeited.
- (xxi) The bidder shall complete the work within 21 days of award of the tender. Penalty @ of Rs. 1000 per day will be recovered from the Bill for delay up to 10 days and after that, the order will be cancelled and performance security forfeited.
- (xxii) In case of breach of any terms and conditions attached to the tender document, the Performance Security Amount of the agency will be liable to be forfeited by this Commission besides annulment of the work order.
- (xxiii) After completion of the contractual obligations, including supply / installation / integration and commissioning of the items, the successful bidder shall raise the bills, in triplicate. PAN Number and or other tax registration numbers should be printed on the bills raised by the successful bidder
- (xxiv) PRICE: The Price quoted shall be all inclusive and firm throughout the quote validity period and not subject to escalation of any kind whatsoever.
- (xxv) VALIDITY OF QUOTES: 60 Days from the Last date of Submission of Quotes.
- (xxvi) Specifications and Terms & Conditions as contained in our tender documents shall be final and binding on all the bidders.

(xxvii) The following documents should be enclosed with the technical bid:

- (e) Brochure of the equipments to be supplied.
- (f) Earnest Money Deposit (EMD) of Rs.60,000/- (Rupees Sixty thousand only) in the form of Demand Draft/Pay Order from a commercial bank drawn in favour of "Pay & Accounts Officer, Planning Commission, New Delhi".
