General information & terms and conditions

- 1. The successful bidder will have to supply, install, test and commission (SITC) the equipments within 7 days from the date of placing the order.
- 2. Details / specifications of items required are given in the tender document.
- 3. Colour picture catalogues of the item should be attached with the Technical Bid.
- 4. The tenderers are required to submit two separate bids Technical and Financial, as per proforma given in the tender document. The two bids should be put in two separate sealed envelopes superscribed "Technical Bid" and "Financial Bid". Both sealed envelopes should be put in a third sealed envelope superscribed "Tender for supply of PTZ Cameras to Planning Commission". The Technical Bid is in two parts, consisting of Technical Bid (A) and Technical Bid (B). Both the parts, viz., (A) & (B) should be put in a single sealed enveloped superscribed Technical Bid.
- 5. The declaration in the prescribed proforma given in the tender document should be submitted alongwith the Technical Bid.
- 6. Technical Specifications of the IP Based PTZ Cameras

Item Particulars and specifications

- PTZ cameras with features like left, right, up, down, zooming in, zooming out, programming, etc. should be controllable from control room located at a different place than the place of installation of cameras.
- The cameras should be IP based and fully digital without having any external encoder circuit/ web server, etc..
- The camera features should be quickly and easily accessible by provision of on-screen displays. Cameras and the Network Management System should be of the same company / brand, etc.
- Cameras should have regulatory compliance certification from U. L.
- The camera view should be viewable on standard web browser, viz., internet explorer and should not require any special viewer software.
- The system should be a network enabled High Resolution Pan/Tilt Zoom Camera, capable of 340 degree pan rotation and a tilt range of 90 degrees utilizing a ¼" type CCD The camera shall also provide an analog video output producing 460 TV lines of horizontal resolution.
- Should have minimum 18X optical, auto focus zoom lens, and minimum 12X digital zoom capability, network interface should be 10 Base T /100 Base TX Ethernet.
- The system should facilitate Interactive PTZ control whereby the camera's PTZ functions can be controlled by simple mouse click on the live video image of the particular IP PTZ camera. This feature should be available when accessing through the Internet explorer, on any networked PC. Also, this feature should be in addition to the soft PTZ control toolbar menu on the application software / web page.
- Should be capable of streaming both MPEG4 and JPEG data simultaneously & also unicast or multicast capability for MPEG4
- Should be able to utilize hardware based PKI Technology that sends a digital signature along with the video data from the camera to authenticate the images and the source of the image.
- Should support minimum Fixed 16 user defined presets. Each preset shall allow minimum 4 user defined windows for motion detection or object detection.
- Should have frame rate capability over LAN of up to 25 frames per second, VGA size, in either MPEG4 or JPEG, and up to 25 frames per second on dual stream mode of MJPEG and MPEG 4, at a capture size of QVGA.
- Should have built-in PC card slot to allow the use of additional ATA memory, or allow the use of a manufacturer specified compact flash wireless LAN card via a PC card type II adaptor.
- Should have Internal Image storage of Minimum 6MB for Pre-/Post alarm & shall be expandable up to 1GB through Expansion Card Slot.

• Power requirements shall be AC 24V 50 Hz or DC 12V.
