- 1. The tenders are being invited to empanel agencies for providing the services of DLY / DLZ Cars to Planning Commission on rate contract basis.
- 2. Only registered and bona fide firms having a minimum of 10 self owned cars, possessing requisite experience, competence, capacity to provide requisite number of cars even at short notice and having a minimum annual turnover of Rs.20,00,000/- (Rs.Twenty lakhs only) during the last two years in this line of business need apply. In other words, the bidder / bidding company should have a minimum of 10 self owned cars in his own name / the company's own name. This condition cannot be substituted by providing authorisation letters from taxi service providers.
- 3. The vehicles must have DLY registration numbers from the Authority situated in the NCR.

- 7. The declaration in the prescribed proforma should be submitted alongwith the technical bid.
- 8. The Technical bid should be accompanied by an Earnest Money Deposit (EMD) of Rs.50,000/- (Rupees fifty thousand only) in the form of Demand Draft/Pay Order from a commercial bank drawn in favour of "Pay & Accounts Officer, Planning Commission, New Delhi". It should remain valid for a period of 6 months. In the absence of EMD, the tender shall be rejected summarily. - 9. - 10. The contract will be initially for a period of one year from the date of commencement. The period of the contract may be extended on a yearly basis upto a maximum of 3 years, on request by the firm, on the same terms and conditions, provided the requirement of Planning Commission persists at that time and subject to qualitative assessment of the performance of the firm by the competent authority in Planning Commission.

- 11. The make of the cars deputed for duty should not be older than year 2006.
- 12. Documents in support of the vehicles being owned by agency has to be submitted with the technical bid.
- 13. The agency must have a 24 /7 office environment, so that the agency can be telephonically contact at any time.
- 14. The drivers must be at least 40 years of age and possessing a valid commercial Driver's Licence.
- 15. The Drivers must be well experienced, well behaved, wearing neat and clean uniform, having thorough knowledge of the routes in Delhi/NCR and have a permanent mobile contact number.
- 16. The taxis being provided must be in excellent condition, with immaculate seat covers and bearing DLY / DLZ numbers.
- 17. There will be a penalty of Rs.100/- per day per vehicle for (a) the Driver not wearing uniform; (b) not possessing the cell phone; and (b) the vehicle not having been cleaned while reporting for duty.
- 18. Drivers / vehicles attached to Sr. Officers on a regular basis should not be changed without prior permission / intimation.
- 19. All vehicles must be fully insured and have valid pollution control certificates.
- 20. Expenditure on account of claims arising out of accidents, challans for traffic violations, etc. will be borne by the service provider.
- 21. Payment will be made on a monthly basis. Bills sent by the agency shall be accompanied by Log Book and Duty slips.
- 22. Dead mileage will not be paid. Mileage will be calculated from Planning Commission.

- 24. The approved rates will remain valid during the entire period of one year of the contract and request for enhancement of rates will not be agreed to during this period.
- 25. In case the agency fails to provide vehicle(s) for a particular duty, etc. vehicles will be hired from other sources and the difference between the approved rate and the rates of the other source will be recovered from the subsequent bills of the agency. Same will apply in case the agency fails to provide an alternate vehicle in case of breakdown, etc.

The drivers deployed by the agency in this Commission shall not have claims of any Master and Servant relationship against Planning Commission.

- 28. The service providing agency shall be solely responsible for the redressal of grievances/resolution of disputes relating to the drivers. This Commission shall, in no way, be responsible for settlement of such issues whatsoever.
- 29. This Commission shall not be responsible for any financial loss or other injury to any driver deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.
- 30. The driver(s) deployed by the service providing agency shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular / confirmed employees of this Commission during the currency or after expiry of the contract.
- 31. The Drivers shall report for duty to Incharge, Staff Car Cell, Planning Commission and produce duty slip, PUC Certificate, valid Driver's Licence, RC book etc., and mark his attendance in the attendance registered kept in the Staff Car Cell.
- 32. The Driver shall report back to the Incharge Staff Car Cell after conclusion of his duties, and produce parking / toll fees slips, if any paid by him and get it signed from the Incharge.
- 33. The Driver shall also maintain a Log Book and get the opening and closing meter reading, opening and closing time signed from Incharge, Staff Car Cell on each day of duty.
- 34. In case of termination of this contract on its expiry or otherwise, the driver(s) deployed by the service providing agency shall not be entitled to and will have no claim for any absorption in the regular / otherwise capacity in this Commission.
- 35. The agency will be responsible for compliance of all statutory provisions relating to Minimum Wages, etc. in respect of the drivers deployed by it in this Commission. The tendering agency will be fully responsible for payment of wages and other dues and compliance of all labour laws, welfare schemes applicable to the drivers deployed by them in this Office.
- 36. The agency shall be liable for depositing all taxes, levies, Cess etc. on account of services rendered by it to Planning Commission to concerned tax collection authorities from time to time as per extent rules and regulations in the matter.
- 37. The agency shall maintain all statutory registers under the Law. The agency shall produce the same, on demand, to the concerned authority of this Commission or any other authority under Law.
- 38. If the agency fails to start providing vehicles as per the requirement of Planning Commission, within 7 days from date of placing the order, the EMD shall be forfeited without giving any further notice.
- 39. In case, the agency fails to comply with any statutory/taxation liability under appropriate law, and as a result thereof the Commission is put to any loss/obligation, monetary or otherwise, the Commission will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the agency, to the extent of the loss or obligation in monetary terms.
