- 1. The bidder should be authorized Registered Supplies Reseller of Hp brand and should be in a position to deliver the Hp consumables to Planning Commission, Yojana Bhavan, Sansad Marg and also to Economic Advisory Council to PM, Vigyan Bhavan Annexe.
- 2. The bidder must have had/ have been supplying Hp consumables to at least two Govt. departments. Supportive documents in respect of their satisfactory supplying of Hp consumables must be attached with the bid form.
- 3. Firm/ bidder must have valid TIN/ Sales Tax Registration No.and have printed on the firm's letterhead.
- 4. Only original Hp cartridges are to be delivered for which the rates are to be quoted in the bid form. Contract will be outrightly annulled in case any fake/ spurious or recycled cartridges are supplied. In such situation, the earnest money deposited with Planning Commission will stand forfeited and the firm will be blacklisted for any participation of supply of goods/ services in future in Planning Commission.
