EOI Notice dated December 4, 2012

Request for Proposal for Evaluation Study of Performance of National Institute of Pharmaceutical Education & Research (NIPER), Mohali, an autonomous institution under Department of Pharmaceuticals

A. Background, Objectives & Scope of the Assignment/ Study

- 12th Plan Steering Committee on Industry has prepared a Manufacturing Plan as a part of 12th Plan exercise. The objective is to achieve growth of domestic manufacturing @ 2-4% more than GDP growth so as to increase share of manufacturing in GDP to 25% and create 100 million additional jobs by 2025.
- 2. The Manufacturing Plan recognizes pharmaceutical sector as one of the drivers for manufacturing growth and emphasizes on laying dedicated focus on boosting domestic research and development so as to accelerate new drug delivery especially in the areas of neglected diseases, vector borne diseases, other areas of public health etc. It has been felt that NIPER, Mohali, which was set up as an 'Institute of National Importance' for imparting training and education in various streams of pharmaceutical sciences/ engineering and conducting research work in pharmaceutical sector, has to assume a stellar role in the areas of drugs and pharmaceutical research.
- 3. In the light of the above, it is decided to go for a comprehensive evaluation study of the performance and capability of NIPER, Mohali. The objective of the said study is to have an idea of readiness/ preparedness of NIPER, Mohali to take the intended role and function, as indicated above as well as to know the areas requiring additional focus and efforts.
- 4. The Terms of Reference (TORs) of the proposed Study are as follows.
 - (i) To examine the year-wise funding/ support provided by GOI to NIPER, Mohali vis-à-vis the facilities created i.e. plant & machinery, infrastructure etc. and utilization thereof;
 - (ii) To assess capability of NIPER, Mohali in terms of facilities and strength and attributes of faculty members/ experts and researchers to impart quality education & training as well as carrying out research work;
 - (iii) To evaluate performance of NIPER, Mohali in terms of :
 - a) Quality of education (growth in demand/ intake, placement of students, growth of research students etc.)
 - b) Research output (no. of research projects, no. of papers, effectiveness of research in terms of patents filed, new drug developments, commercialization etc.)
 - c) Industry interface Projects awarded by industry, research output acquired by industry, linkage with industry/ research organization in country and abroad etc.

To identify the shortcomings/ deficient areas and suggest remedial measures;

(*iv*) SWOT Analysis of the institute in terms of its intended role and relevance for becoming a major R&D hub in drugs and pharmaceuticals in 12th Plan period; and

(v) Recommendation and way forward

5. Apart from primary note of research investigation at the institute level, the study should also rely on inputs from leading domestic drug manufacturers in regard to their perception about NIPER, Mohali and suggestions, if any, for further improvement.

B. Request for Proposal

6. Adviser (Industries), Planning Commission, for and on behalf of the President of India, hereby invites proposals from qualified consulting firms or expert institutions having adequate experience of performance evaluation of Government programmes/ organisations and conducting primary research/ survey for taking up the assignment as indicated in the Section A above. The proposal has to be **submitted positively within fifteen (15) days** from date of the uploading of the EOI Notification in the Planning Commission Website.

C. Validity of Proposal

7. The proposal should be valid for a period not less than **sixty (60) days** from the due date for receiving the proposal.

D. Eligibility

- 8. The firm should meet the following criteria
- 8.1 The consulting firm/ expert institution should have at least ten years' experience in consulting, performance study and evaluation of programmes/ organisations.
- 8.2 The firm/ organization having exposure in dealing with Government sponsored assignment/ work and expertise in study in drugs and pharmaceutical sector shall be preferred.

E. Brief Description of the Selection Process

9. A two stage selection process will be adopted in evaluating the Proposals. In the first stage, a technical evaluation will be carried out. In the second stage, a financial evaluation will be carried out. Proposals will finally be ranked according to their combined technical and financial scores. The first ranked Institution shall be selected while the second ranked Institution will be kept in reserve.

F. Timeframe

10. The assignment shall be for a period of **45 days.** Draft inputs shall be made available from time to time as per requirement and shall be finalized after discussions with the Planning Commission. The Final Report has to be made available to Planning Commission **within 45 days**.

G. Right to reject any or all Proposals

- 11. Notwithstanding anything contained in this RFP, the Planning Commission reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection, or annulment, and without assigning any reasons thereof.
- 12. The Planning Commission reserves the right to reject any Proposal if:
 - a) At any time, a material misrepresentation is made or uncovered; or,
 - b) The Consultant/ Institution does not provide, within the time specified by the Planning Commission, the supplemental information sought by the Planning Commission for evaluation of the Proposal.

H. Submission of Proposals

13. The Proposal shall be typed or written in indelible ink and signed by the Authorized Signatory of the firm, who shall initial each page, in blue ink. All the alterations, omissions, additions, or any other amendments made to the Proposal shall be initialed by the person(s) signing the Proposal. The Proposals must be properly signed as detailed below:

While submitting the Technical Proposal, the Firm shall, in particular, ensure that:

- a) CVs of the experts have been submitted;
- b) Applicant organization meets the Conditions of Eligibility;
- c) The CVs have been recently signed in blue ink by the individual and the Team Leader. Photocopy or unsigned / countersigned CV shall be rejected; and
- d) The CV shall contain an undertaking from the Team member about his/her availability for the entire period of report preparation.
- 14. Failure to comply with the requirements spelt out in Clause 10 above shall make the Proposal liable to be rejected.
- 15. If a firm/ organization or any of its members make(s) an averment regarding his or their qualification, experience, or other particulars and it turns out to be false, or his commitment regarding availability for the Project is not fulfilled at any stage after signing of the Letter of Acceptance, all the members of the organization shall be debarred for any future assignment of the Planning Commission for five years.
- 16. The Technical Proposal shall not include any financial information relating to the Financial Proposal.
- 17. The Planning Commission reserves the right to verify all statements, information, and documents, submitted by the Applicant in response to the RFP. Failure of the Planning Commission to undertake such verification shall not relieve the firm of its obligations or liabilities hereunder nor will it affect any rights of the Planning Commission thereunder.
- 18. In case it is found during the evaluation or at any time before issue of Letter of Acceptance (LOA) that one or more of the eligibility conditions have not been met by the firm or the Team has made material misrepresentation or has given any materially incorrect or false information, the firm shall be disqualified forthwith if not yet appointed as the Consultant. If the firm has already been issued the LOA the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Planning Commission without the Planning Commission being liable in any manner whatsoever to the Applicant.
- 19. The Proposal will be sealed in an outer envelope, which will bear the address of the Planning Commission, RFP Notice No., Consultancy name, and the name and address of the Team Leader. It shall bear on top, the following:

"Do not open, except in presence of the Authorized Person"

If the envelope is not sealed and marked as instructed above, the Planning Commission assumes no responsibility for the misplacement or premature opening of the contents of the Proposal submitted.

- a) The aforesaid outer envelope will contain two separate sealed envelopes; one clearly marked "Technical Proposal" and the other clearly marked "Financial Proposal". The envelope marked "Technical Proposal" shall contain the Application in the prescribed format along with relevant Forms and supporting documents.
- b) The envelope marked "Financial Proposal" shall contain the financial proposal in the prescribed format.
- 20. The Technical Proposal and Financial Proposal shall be typed or written in indelible ink and signed by the authorized signatory of the firm. All pages of the original Technical Proposal and Financial Proposal must be numbered and initialed by the authorized signatory (on behalf of the firm) signing the Proposal.
- 21. The completed Proposal must be delivered on or before the specified time on the due date as per Clause 23. Proposals submitted by fax or e-mail shall not be entertained.
- 22. The Proposal shall be made in the Forms specified in this RFP. Any attachment to such Forms must be provided on separate sheets of paper and only information that is directly relevant should be provided. This may include photocopies of the relevant pages of printed documents.
- 23. The rates quoted shall be firm throughout the period of performance of the assignment up to and including acceptance of the Report by the Planning Commission and discharge of all obligations of the Consultant under the Agreement.

I. Financial Proposal

- 24. Applicants shall submit the financial proposal in the Forms at Annex 3 clearly indicating the total cost of the Consultancy in both figures and words, in Indian Rupees, and signed by the authorized signatory of the firm. In the event of any difference between figures and words, the amount indicated in words shall be taken into account. In the event of a difference between the arithmetic total and the total shown in the Financial Proposal, the lower of the two shall be taken into account.
- 25. While submitting the Financial Proposal, the firm shall ensure the following:
 - a) All the costs associated with the assignment shall be included in the Financial Proposal. These shall normally cover remuneration for all the Personnel, accommodation, travelling, printing of documents, taxes etc. The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption, and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered nonresponsive and liable to be rejected.
 - b) The Financial Proposal shall take into account all expenses and tax liabilities. For the avoidance of doubt, it is clarified that all taxes shall be deemed to be included in the costs shown under different items of the Financial Proposal. Further, all payments shall be subject to deduction of taxes at source as per applicable laws.
 - c) Costs (including break down of costs) shall be expressed in INR.

J. Proposal Due Date

23) The proposals should be submitted on or before 11.00 hours on December 20, 2012 to:

K. Late Proposals

- 24) Proposals received by the Planning Commission after the specified time on the due date shall not be eligible for consideration and shall be summarily rejected.
- 25) Any alteration / modification in the Proposal or additional information or material supplied subsequent to the due date, unless the same has been expressly sought for by the Planning Commission, shall be disregarded.

L. Evaluation Process

- 26) The Planning Commission shall open the Proposals at 11.30 hours on the due date, and in the presence of the Applicants who choose to attend. The envelopes marked "Technical Proposal" shall be opened first. The envelopes marked "Financial Proposal" shall be kept sealed for opening at a later date.
- 27) Prior to evaluation of Proposals, the Planning Commission will determine whether each Proposal is responsive to the requirements of the RFP. A Proposal shall be considered responsive only if:
 - a) it is received in the specified format;
 - b) it is received by the due date including any extension thereof;
 - c) it is signed, sealed and marked as stipulated;
 - d) it contains all the information (complete in all respects) as requested in the RFP;
 - e) it does not contain any condition or qualification; and
 - f) it is not non-responsive in terms hereof.
- 28) The Planning Commission reserves the right to reject any Proposal, which is non-responsive and no request for alteration, modification, substitution, or withdrawal shall be entertained by the Planning Commission in respect of such Proposals.
- 29) The Technical Evaluation will be in the following format.

30) After the technical evaluation, the Planning Commission would prepare a list of pre-qualified Applicants for opening of their Financial Proposals. The opening of Financial Proposals shall be done in presence of Applicants who choose to be present. The Planning Commission will not entertain any query or clarification from Applicants who fail to qualify at any stage of Selection Process.

M. Clarifications

31) To facilitate evaluation of Proposals, the Planning Commission may, at its sole discretion, seek clarifications from any Applicant regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Planning Commission for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing. If a Team does not provide clarifications sought above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Planning Commission may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding.

N. Evaluation of Technical Proposals

- 32) In the first stage, the Technical Proposal will be evaluated on the basis of the experience of the firm. Only those Applicants whose Technical Proposals score 70 marks or more out of 100 shall qualify for further consideration, and shall be ranked from highest to the lowest on the basis of their technical score (ST).
- 33) The scoring criteria to be used for evaluation shall be based on the number of years of experience and its relevance to the proposed scope of work. The minimum eligibility will be determined on the basis of minimum requirement of experience of having worked in economic studies and econometric models as indicated above. For additional years of experience, additional weightage shall be accorded on a pro-data basis. For the purpose of experience in strategy formulation, weightage would be given on the number of years of experience in preparing strategy.

O. Evaluation of Financial Proposal

- 34) In the second stage, the financial evaluation will be carried out and each Financial Proposal will be assigned a financial score (SF).
- 35) For financial evaluation, the total cost indicated in the Financial Proposal will be considered.
- 36) The Planning Commission will determine whether the Financial Proposals are complete, unqualified and unconditional. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services. Omissions, if any, in costing any item shall not entitle the Team to be compensated and the liability to fulfill its obligations as per the TOR within the total quoted price shall be that of the Consultant. The lowest financial proposal (FM) will be given a financial score (SF) of 100 points. The financial scores of other proposals will be computed as follows: S_F = 100 x F_M/F (F = amount of Financial Proposal)

P. Combined Technical and Final Evaluation

37) Proposals will finally be ranked according to their combined technical (ST) and financial (SF) scores as follows:

 $S = S_T \mathbf{x} T_w + S_F \mathbf{x} F_w$

Where S is the combined score, and T $_{\rm w}$ and F $_{\rm w}$ are weights assigned to Technical Proposal and Financial Proposal that shall be 0.80 and 0.20 respectively.

38) The Selected Team shall be the first ranked firm (having the highest combined score). The second ranked firm shall be kept in reserve in case the first ranked firm withdraws, or fails to comply with the requirements as the case may be.

Q. Award of Study

39) After selection, a Letter of Award shall be issued, in duplicate, by the Planning Commission to the Selected Firm and the Firm shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. The LOA shall constitute the Agreement for the purpose of this consultancy assignment.

R. Proprietary data

40) All documents and other information provided by the Planning Commission or submitted by a firm to the Planning Commission shall remain or become the property of the Planning Commission. Firms are to treat all information as strictly confidential. The Planning Commission will not return any Proposal or any information related thereto. All information collected, analyzed, processed, or in whatever manner provided by the Consultant to the Planning Commission in relation to the Consultancy shall be the property of the Planning Commission.

S. Deliverables and Payment to the Consultant

41) Billing and payments in respect of the Services shall be made as follows:-

- 42) The Planning Commission shall cause the payment due to the firm to be made within 30 (thirty) days after the receipt by the Planning Commission of duly completed bills with necessary particulars.
- 43) All payments under this Agreement shall be made to the bank account specified by the firm as may be notified to the Planning Commission by the Consultant.

T. Performance Security

44) The Planning Commission shall retain by way of performance security 5 % (five percent) of all the amounts due and payable to the firm, to be appropriated against breach of this Agreement or for recovery of liquidated damages. The balance remaining out of the Performance Security shall be returned to the Team at the end of three months after the expiration of the contract.

U. Liquidated Damages for error/variation

45) In case any error or variation is detected in the reports submitted by the firm and such error or variation is the result of negligence or lack of due diligence on the part of the firm, the consequential damages thereof shall be quantified by the Planning Commission in a reasonable

manner and recovered from the Consultant by way of liquidated damages, subject to a maximum of 10 % (ten percent) of the Contract Value.

V. Liquidated Damages for delay

46) In case of delay in completion of Services, liquidated damages not exceeding an amount equal to 0.2 % (zero point two percent) of the Contract Value per day, subject to a maximum of 10 % (ten percent) of the Contract Value will be imposed and shall be recovered by appropriation from the Performance Security or otherwise. However, in case of delay due to reasons beyond the control of the Consultant, suitable extension of time shall be granted.

W. Appropriation of Performance Security

47) The Planning Commission shall have the right to appropriate the Performance Security, in whole or in part, without notice to the firm in the event of breach of Agreement or for recovery of liquidated damages.

X. Miscellaneous

48) The Selection Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Delhi shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Selection Process.
