



General Terms & Conditions:

1. Bidders may inspect the items on the dated and time, as mentioned above.
2. The items shall be sold off to the highest bidder. The bids are invited for the Part -A lot (i.e. all the items contained in the list of obsolete/unserviceable Tyres & Tubes/scrap materials in Part A of Annexure "A") and the waste paper mentioned in Part-B of Annexure "A". A bidder can bid for either the lot mentioned at Part A of Annexure "A" or the waste paper as mentioned at Part B of Annexure "A" or for both and may fill in the format enclosed as Annexure "B" accordingly.
3. List of items are given at Annexure "A", Part A and Part B.
4. The Earnest Money Deposit(s) (EMD) of successful bidder(s) shall be adjusted either from the total payment or released after receipt of full payment as per the quoted rates.
5. The successful bidder(s) has/have to make full balance payment(s), after due adjustment of the EMD(s), in the form of Demand Draft(s) in favour of "Pay & Accounts Officer, Planning Commission, payable at New Delhi" within three days after confirmation, failing which the offer will be cancelled and the EMD(s) shall stand forfeited. The EMD(s) of unsuccessful bidder(s) shall be returned within one month after the auction date, without any interest.
6. No item, once sold off to the successful bidder shall be taken back by this Department on any condition whatsoever.
7. The successful bidder(s) will be required to lift all the items from the disposal site within three days after the payment of the balance amount. On failure to do so, this Department shall have the right to forfeit the entire amount(s) deposited by the bidder(s) and dispose of the items to alternate bidder(s). The successful bidder(s), on their own cost, will also be required to make their own arrangements as regards of transport, labour, etc., for lifting the disposal items.


