<u>Terms & Conditions</u> for supply of Water through Water Tankers in Planning Commission

- 1. The quotation should be sent in the proforma attached as Annexure I. The last date for receipt of quotation is 3.00 p.m. on 29-4-2008 (Tuesday) and quotations will be opened at 3.30 p.m. in room no. 411 in the presence of such tenderers who may wish to be present.
- 2. The water in water tanker shall be delivered at Yojana Bhavan, Planning Commission, New Delhi and the water should be pumped from the water tanker to the Water Tanks at Ground floor of Yojana Bhavan.
- 3. The contract shall be effective from the date it is awarded/formalities completed and remain in force till 30-4-2009 or until further orders, whichever is earlier. The period of contract can be extended by Planning Commission after 30-4-2009, at its discretion.
