### **General information & terms and conditions**

- 1. The bids should be submitted on company letter head with separately sealed Technical and Financial bids filled as per Performa given below and put in a third sealed envelope superscribed "Tender for empanelment as registered supplier of telephone instruments and related items".
- 2. The quotations may be sent by post to the Under Secretary (GA) at the above mentioned address by the stipulated date and time. The tenders can also be dropped in the Tender Box which will be placed at Reception Area of Yojana Bhawan, New Delhi for four working days and during working hours from 08/08/2011 to 11/08/2011. The bids can be submitted upto 3.00 P.M. on 11/08/2011.
- 3. The <u>bids shall be opened on the same day at 3.30 PM</u> by the Tender Opening and Evaluation Committee (TOEC), comprising of a group of Officers of Planning Commission, in the presence of such tenderers or their authorized representatives who may wish to be present at the time of opening of the tenders.
- 4. The Financial Bids of only those tenderers will be opened whose Technical bids fulfil the eligibility criteria conditions and have been accepted by the TOEC.
- 5. The tenderer should be an authorised dealer for the product digital line card, cordless telephone instruments, push button type telephone instruments and Plan 1+1 telephone instruments, for which he is bidding for and attach dealership authorisation letter(s) from original equipment manufacturer(s)/ national/regional distributor(s). The letter(s) should be with reference to this tender, addressed to the Under Secretary (Genl. Admn.), Planning Commission and submitted with the Technical Bid.
- 6. The lowest bidder for each item will be selected / empanelled for supply of that particular item, subject to his having fulfilled all other conditions.

- 11. The contract can be terminated without assigning any reason therefor, at the discretion of Planning Commission, at any time, by giving one month's notice.

- 12. The Technical bid should be accompanied by an Earnest Money Deposit (EMD) of Rs.5,000/- (Rupees five thousand only) in the form of Demand Draft/Pay Order from a commercial bank drawn in favour of "Pay & Accounts Officer, Planning Commission, New Delhi".
