The Annual Plan meeting for 2012-13 of Bihar between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on June 27, 2012.

2. The Aggregate Resources of Bihar at the Official level were identified at Rs.27,749 crore including Rs.1500 crore under Special Plan for Bihar for the ongoing projects. Deputy Chairman, Planning Commission agreed to provide One Time Additional Central Assistance (Grants) of Rs.51 crore. The One Time Additional Central Assistance is to be utilized for identified projects to be approved by the Planning commission.

3. Taking this into consideration the above, the Annual Plan size of Bihar for 2012-13 has been finalized at **Rs.28,000 crore**.

4. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Bihar is enclosed at **Annex- I**. The details of Scheme wise Additional Central Assistance are enclosed at **Annex-II**.
