The aggregate Plan Resources of NCT of Delhi assessed at Rs. 15,862 crore for funding the given plan size include UT's Own Funds of Rs. 15,139.79 crore, and Central Assistance of Rs.1160.21 crore. Central Assistance further consists of Normal Central Assistance of Rs.281.75 crore, ACA for EAP of Rs. 60.21 crore and ACA for other programmes/schemes of Rs.818.25 crore.
- 4. The Scheme of Financing for Annual Plan 2012-13 and ACA for other schemes is enclosed at Annexure-I and Annexure-II, respectively and Balance on Current Revenues is given at Annexure-III.
