Subject: Annual Plan 2012-13 – MAHARASHTRA – Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 29<sup>th</sup> May, 2012 - Note on Scheme of Financing for inclusion in the minutes of the S.P. Division/ Summary Record.

The Annual Plan meeting for finalization of the Plan Size for 2012-13(AP) for Maharashtra between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 29<sup>th</sup> May, 2012.

- 2. The size of the Annual Plan 2012-13 of the State has been fixed at Rs.45000 crore including the allocation of Rs.2400 crore for Accelerated Irrigation Benefit Programme (AIBP). In addition, Deputy Chairman has agreed to provide One Time Additional Central Assistance (OTACA) of Rs.90 crore (Grant component), which would enable OTACA projects worth Rs. 300 crore at the State level.
- 3. The State Government Resources of Rs. 45000 crore comprise Rs.14549.11 crore as State's Own Resources (non-loan portion), State's Borrowings of Rs.22651.26 crore and Rs.7799.63 crore of Central Assistance. Central Assistance further includes Normal Central Assistance of Rs.773.24 crore, Rs.57.03 crore of Additional Central Assistance (ACA) for Externally Aided Projects (EAPs) and ACA for Other schemes of Rs. 6969.36 crore.
- 4. In addition to above it was also agreed that State Public Sector Enterprises (Internal & Extra-Budgetary Resources) for investments would be of Rs.26000 crore.
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Maharashtra is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-II and Balance from Current Revenue are at Annex- III.
