Subject: Annual Plan 2012-13-MEGHALAYA - Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 7th June,2012 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2012-13 for Meghalaya between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 7th June,2012.

- 2. The aggregate resources of Meghalaya at the official level were identified at Rs.2910 crore. The Statutory borrowings (net) for Meghalaya for 2012-13 is Rs. 546 crore which is the same as the borrowing ceiling as per the Ministry of Finance. During the discussions, the Deputy Chairman, Planning Commission agreed to provide Special Plan Assistance/ Special Central Assistance of Rs. 800 crore (grants). This includes Special Plan Assistance of Rs. 500 crores (grants) and Special Central Assistance (untied) of Rs. 300 crore. The Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission. In addition, Deputy Chairman, Planning Commission also agreed to provide Additional Central Resources (SPA) of Rs. 229 crore for Special Projects subject to availability of resources from Ministry of Finance.
- Taking the above resources into account the Annual Plan size of the State of Meghalaya for 2012-13 (AP) was finalized at **Rs. 3939 crore**.
- 4. The Aggregate Resources of Rs.3939 crore comprise Rs.294.55 crore of State's Own Resources (non-loan portion), Rs.546 crore of State's Borrowings (net), Rs.2698.45 crore of Central Assistance (grants) and Rs. 400 crore of resources of Public Sector Enterprises.
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Meghalaya is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-II and Balance from Current Revenue are at Annex- III.
