Subject: Annual Plan 2012-13 NAGALAND - Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 26th June, 2012 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2012-13(AP) for Nagaland between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 26^{th} June, 2012.

- 2. The aggregate resources of Nagaland at the official level were identified at **Rs.1032** crore. The Statutory borrowings (net) for Nagaland for 2012-13 is Rs. 459 crore which is the same as the borrowing ceiling as per the Ministry of Finance. During the discussions, the Deputy Chairman, Planning Commission agreed to provide Special Plan Assistance (SPA) / Special Central Assistance (SCA) of Rs. 1268 crore (grants). This comprises Special Plan Assistance of Rs. 218 crore (grants) and Special Central Assistance (untied) of Rs. 750 crore. In addition, it was agreed to provide Special Plan Assistance Package for Eastern Nagaland Region of Rs. 300 core subject to availability of additional resources from Ministry of Finace. The Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission.
- Taking the above resources into account the Annual Plan size of the State of Nagaland for 2012-13(AP) was finalized at **Rs. 2300 crore**.
- 4. The Aggregate Resources of Rs. 2300 crore comprise of State's Own Resources (non-loan portion) of Rs. (-) 848 crore, State's Budgetary Borrowings (Net) of Rs.459 crore and Central Assistance of Rs.2689 crore.
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Nagaland is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-II and Balance from Current Revenue are at Annex- III.
