The Annual Plan meeting for 2012-13 of Odisha between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on May 04, 2012.

- 2. The Aggregate Resources of Odisha at the Official level were identified at Rs.17,200 crore. Deputy Chairman, Planning Commission agreed to provide One Time Additional Central Assistance (Grants) of Rs.50 crore. The One Time Additional Central Assistance is to be utilized for identified projects to be approved by the Planning commission.
- 3. Taking this into consideration, the Annual Plan size of Odisha for 2012-13 has been finalized at **Rs.17,250 crore**.
- 4. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Odisha is enclosed at **Annex-I**. The details of Scheme wise Additional Central Assistance are enclosed at **Annex-II**.
