Subject: Note on Scheme of Financing for inclusion in the minutes of SP Division for Annual Plan 2012-13 of Rajasthan.

Aggregate Plan Resources for the Annual Plan 2012-13 of Rajasthan were assessed at Rs. 33,440 crore at the official level discussions.

- 2. Subsequently, during the discussions of the Chief Minister with the Deputy Chairman, Planning Commission on 21.3.2012 it was agreed that the aggregate plan resources would be raised by Rs. 60 crore due to one time Additional Central Assistance (grant) for State specific projects. Borrowings of the State are Rs.456 less than the ceiling specified by the Ministry of Finance.
- 3. The Annual Plan for Rajasthan for 2012-13 was approved at Rs.33,500 crore after taking into account all the resources of the State.
- 4. The aggregate Plan resources of Rs. 33,500 crore consists of State Government's Own funds of Rs. 7024 crore, State's budgetary borrowings of Rs. 10844 crore, Central Assistance of Rs.3477 crore, which includes Normal Central Assistance of Rs. 647 crore, ACA for EAPs of Rs. 254 crore and Rs.2576 crore as other Central Assistance.
- 5. A copy of the detailed scheme of financing for the approved Annual Plan 2012-13 and other Central Assistance are enclosed at Annex-I and IA, respectively. The details of Balance from Current Revenues is at Annex-II.
