Subject: Annual Plan 2012-13 – SIKKIM – Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 13th April 2012 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2012-13(AP) for Sikkim between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 13th April 2012.

2. The aggregate resources of Sikkim at the official level were identified at Rs.1207 crore. The borrowing ceiling for Sikkim for 2012-13 is Rs. 244 crore as per Ministry of Finance. Subsequently, during the discussions, it was agreed that the resources for the Annual Plan would increase by Rs. 12 crore under ACA for Accelerated Irrigation Benefit Programme (AIBP) and Rs. 50 crore under Jawaharlal Nehru National Urban Renewal Mission (JNNURM). It was also agreed to provide Rs.608 crore as Special Plan Assistance (SPA)/ Special Central Assistance (SCA) comprising Rs. 158 crore of SPA(regular), SCA (untied) of Rs. 250 crore and SPA (PM's Package) of Rs. 200 crore. The Special Plan Assistance (PM's Package) is to be utilized for Earthquake Reconstruction and Rehabilitation works and the Special Plan Assistance is for identified projects.

3. Taking the above resources into account the Annual Plan size of the State of Sikkim for 2012-13(AP) was finalized at **Rs.1877 crore** which includes Rs.377 crore of Prime Minister's Package for Earthquake Reconstruction and Rehabilitation.

4. The Aggregate Resources of Rs.1877 crore comprise Rs.18.99 crore of State's Own Resources (non-loan portion), Rs.244 crore of State's Borrowings and Rs.1614.01 crore of Central Assistance.

5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Sikkim is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-II and Balance from Current Revenue are at Annex- III.
