The Annual Plan meeting for finalization of the Plan Size for 2012-13(AP) for Tripura between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on March 29, 2012.

- 2. The aggregate resources of Tripura at the official level were identified at Rs. **1000** crore. During the meeting, Deputy Chairman, Planning Commission agreed to provide Special Plan Assistance/Special Central Assistance (untied) of Rs. 1250 crore comprising Special Plan Assistance of Rs. 450 crore and Special Central Assistance (untied) of Rs.800 crore. The Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission. Ministry of Finance has indicated the borrowing ceiling of Rs.609 crore for Tripura for 2012-13 (AP).
- 3. Taking the above resources into account the Annual Plan size of the State of Tripura for 2012-13 was finalized at Rs. 2250 crore.
- 4. The Aggregate Resources of Rs. 2250 crore comprise Rs.(-)1278.06 crore of State's Own Resources (non-loan portion), Rs. 609.00 crore of State's Borrowings and Rs. 2919.06 crore of Central Assistance.
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Tripura is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-II and Balance from Current Revenue are at Annex- III.
