#### Subject: Annual Plan 2013-14 – MANIPUR – Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 25<sup>th</sup> April, 2013 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2013-14(AP) for Manipur between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 25<sup>th</sup> April, 2013.

2. At the official level, the aggregate resources of Manipur for 2013-14 were identified at **Rs. 2400 crore**. During the meeting, Deputy Chairman agreed to provide Special Plan Assistance (SPA)/ Special Central Assistance (SCA) of Rs.1250 crore comprising SPA of Rs. 450 crore (Grants) for projects of special importance to the State and Special Central Assistance (untied Grants) of Rs. 800 crore (Grants). Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission.

3. Taking the above resources into account the Annual Plan size of the State of Manipur for 2013-14(AP) was finalized at **Rs. 3650 crore.** 

4. The Aggregate Resources of Rs.3650 crore comprise State's Own Resources (nonloan portion) of Rs.(-)482.36 crore, State's Budgetary Borrowings (net) of Rs.387 crore (the borrowing ceiling as per Ministry of Finance) and Central Assistance (Grants) of Rs.3745.36 crore.

5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2013-14 of Manipur is enclosed at **Annex-I.** The details of Central Assistance to the State Plan are at **Annex-IA** and Balance from Current Revenue details are at **Annex-II**.
