Subject: Annual Plan 2013-14 – SIKKIM – Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 3rd April 2013 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2013-14(AP) for Sikkim between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 3rd April 2013.

- 2. The aggregate resources of Sikkim at the official level were identified at Rs.1452 crore. The borrowing ceiling for Sikkim for 2012-13 is Rs. 312 crore as per Ministry of Finance. Subsequently, during the discussions, it was agreed to provide Rs.608 crore (grants) as Special Plan Assistance(SPA)/Special Central Assistance (SCA) comprising Rs. 108 crore of SPA(regular), SCA (untied) of Rs. 200 crore and SPA (PM's Package) of Rs. 300 crore. The Special Plan Assistance (PM's Package) is to be utilized for Earthquake Reconstruction and Rehabilitation works and the Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission.
- 3. Taking the above resources into account the Annual Plan size of the State of Sikkim for 2013-14 (AP) was finalized at **Rs.2060 crore** which includes Rs.300 crore of Prime Minister's Package for Earthquake Reconstruction and Rehabilitation.
- 4. The Aggregate Resources of Rs.2060 crore comprise (-) Rs.42.51 crore of State's Own Resources (non-loan portion), Rs.312 crore of State's Borrowings and Rs.1790.51 crore of Central Assistance.
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2013-14 of Sikkim is enclosed at **Annex-I.** The details Central Assistance to the State Plan are at **Annex-I.** A and Balance from Current Revenue details are at **Annex-II**.
