Subject: Annual Plan 2013-14 - TRIPURA - Deputy Chairman - Chief Minister Meeting to finalize Plan size held on 29th May, 2013 - Note on Scheme of Financing.

The Annual Plan meeting for finalization of the Plan Size for 2013-14 for Tripura between Deputy Chairman, Planning Commission and the Chief Minister of the State was held on 29th May, 2013.

- 2. The aggregate resources of Tripura at the official level were identified at **Rs. 1225 crore**. The Statutory borrowings (net) for Meghalaya for 2013-14 is Rs. 699 crore which is the same as the borrowing ceiling as per the Ministry of Finance. During the discussions, the Deputy Chairman, Planning Commission agreed to provide Special Plan Assistance/ Special Central Assistance of Rs. 1275 crore (grants). This includes Special Plan Assistance of Rs. 475 crores (grants) and Special Central Assistance (untied) of Rs. 800 crore. The Special Plan Assistance is to be utilized for identified projects to be approved by the Planning Commission.
- Taking the above resources into account the Annual Plan size of the State of Tripura for 2013-14 (AP) was finalized at **Rs. 2500 crore**.
- 4. The Aggregate Resources of Rs. 2500 crore comprise State's Own Resources (non-loan portion) of Rs.(-) 1295.91 crore, State's Borrowings (net) of Rs.699 crore and Central Assistance (grants) of Rs. 3096.91 crore
- 5. A copy of the detailed Scheme of Financing of the approved Annual Plan 2012-13 of Meghalaya is enclosed at Annex- I. The details of Scheme-wise Additional Central Assistance are at Annex-IA and Balance from Current Revenue are at Annex- II.
