Sir,

I am directed to refer to the Govt. of Rajasthan letter No. F.10(10)Plan/Gr.V/2008, dated 21.7.2009 regarding the sectoral break-up of Annual Plan 2009-10 of Rajasthan and to convey the approval of the Planning Commission for the sectoral break-up of the Plan outlay for 2009-10 for Rs. 17322.00 crore.

- 2. The Scheme of Financing of the agreed outlay of the Annual Plan 2009-10 is given at Annexure-I.
- 3. The share of SC & ST population in Rajasthan is 17.2% and 12.6% respectively. The minimum allocation that should have been earmarked for SCSP and TSP is Rs. 2979.38 crore and Rs.2182.57 crore respectively. The allocation now indicated, of RS.2735.49 crore for SCSP and Rs.2115.35 crore TSP fall short of the minimum requirement. The approval of sectoral outlay conveyed by this letter is subject to the State Govt. providing the minimum amount specified above SCSP and TSP with the overall outlay of Rs.17322.00 crore by suitable adjustment and furnishing a copy of revised sectoral outlay to the Planning Commission for approval.
- 4. A statement showing the distribution of the agreed outlay of the Annual Plan 2009-10 among different heads and sub-heads of development, including earmarked outlays is given at Annexure-II.
- 5. I am directed to invite your attention to the procedure for sending adjustment proposal and revision of outlays and to request you to send the adjustment proposal and proposal for revision of outlays fully supported by Revised Scheme of Financing for the Annual Plan 2009-10, if any, together with appropriate justifications, before 31<sup>st</sup> December, 2009.
- 6. Statements showing actual expenditure incurred and the corresponding actual Scheme of Financing of the Annual Plan 2009-10 should be sent to the Planning Commission before **30**<sup>th</sup> **September 2010**.
- 7. The Plan Programmes need to be monitored closely with a view to achieve the financial and physical targets.
