Sir,

I am directed to refer to the Government of Tamil Nadu's letter No. 8171/SP.1/2009 dated 30.08.2010, on the above subject and to convey the acceptance of Planning Commission to the outlay of Rs. 20,068 crores subject to availability of resources. This includes an Additional Central Assistance (ACA) of Rs. 150 crore also.

2. The amounts dealing with the Flagship programmes and the corresponding share of Tamil Nadu that needs to be provided in the State Plans may be adequately arranged so that the State may not lose the share of the central assistance for the Centrally Sponsored Schemes.

3. The proportion of SC population in Tamil Nadu is 19% and that of ST is 1% as per 2001 census. The outlays of Rs. 3827.83 crore and Rs. 38.51 crore have been allocated by Tamil Nadu in the Annual Plan 2010-11 for SCSP and TSP respectively. While the outlay for SCSP confirms to the guidelines of Planning Commission on SCSP and TSP, it does not hold true for TSP. Based on the ST population in the State, the State Government should earmark an outlay of Rs. 200.68 crore for TSP for 2010-11 at the RE stage.

4. A statement showing the distribution of Approved Plan outlay under different heads and sub-heads of development is enclosed. The earmarked outlays for different schemes have also been indicated therein. Approval is being given subject to the condition laid in para 3 above in Annual Plan 2010-11 at the RE stage.

5. Your attention is invited to the procedure for sending adjustment proposal and revision of outlays and request you to send adjustment proposal and proposal for revision of outlays fully supported by the Revised Scheme of Financing (SOF) for the Annual Plan 2010-11, if any, together with appropriate justification, before **December 31, 2010**.

6. Statements showing actual expenditure incurred and the corresponding actual SOF of the Annual Plan 2010-11 could be sent to the Planning Commission before **November 30, 2010**.

7. The Plan Programmes need to be monitored closely with a view to achieve the financial and physical targets.
