2. The Committee would inter-alia, look into the following aspects :
- Implementation of 27% reservation for the OBCs in institutes of higher learning ; and
  - Assessment of additional infrastructure and other requirements for increasing the overall availability of seats to a level so that the present level of seats available to the general category students does not decline.
3. The Oversight Committee would get suitable inputs by the 31<sup>st</sup> July, 2006 regarding the course of action to be adopted for giving effect to the implementation of

reservation in a time bound manner from the Groups to be constituted by the Ministry of Human Resource Development (Department of Secondary & Higher Education) in respect of Technological/Engineering Institutions, Management Education and Central Universities; the Ministry of Agriculture in respect of Agriculture Education; and, the Ministry of Health & Family Welfare in respect of Medical Education.

4. The Committee shall submit its report by the 31<sup>st</sup> August, 2006.
