### ORDER:-

In the Government order first read above the Government have issued orders for forming the State Level Mission for Skill Development under the Chairmanship of Hon'ble Deputy Chief Minister and Hon'ble Minister for Labour as Vice Chairman with Official/Non Official members/ Special invitees.

3. United Nations Organisation has declared the year 2010 as the International Year of Youth. To commemorate the UN declaration and with a view to upgrading the skills of large number of unemployed educated youth in close collaboration with the private sector, the Hon'ble CM announced the launching of a new scheme viz. **“Employable Skill Training for Educated Unemployed Youth”** on the **Independence Day**, 15<sup>th</sup> August 2010. In the Government order third read above, the Government have issued orders for

implementation of the above scheme with the active participation of private sector. The Government have also sanctioned a sum of Rs.50 crores to train and provide employment to one lakh unemployed youth during the year 2010-2011.

4. In the Government order fifth read above, the Government have approved the guidelines for the scheme "Employable Skill Training to the Unemployed Educated Youth" and have approved the proposal for reconstitution of the State Level Committee on Skill Development Mission, as per the guidelines.

5. Accordingly the Government hereby reconstitute the State Level Mission for Skill Development under the Chairmanship of Hon'ble Deputy Chief Minister and Hon'ble Minister for Labour as Vice-Chairman with the following officials and Non officials members.
